

# Information on personal data processing

INTERPROGETTI GENOVA S.R.L., as controller of personal data processing pursuant to articles 13 and 14 of EU Regulation 679/2016 - General Data Protection Regulation ("GDPR"), in compliance with the obligations laid down by the legislator to protect privacy, hereby wishes to inform you in advance both about the use of your personal data, and of your rights, communicating the following:

# a) CONTROLLER AND OTHER PERSONS IN CHARGE

The data controller is INTERPROGETTI GENOVA S.R.L., C.F. 01277080998, with registered office in Via Ilva, 2/9 16128 Genoa (GE) - Italy. The updated list of the subjects responsible for the processing, with the relative areas of competence, is as follows:

- Data controller BERALDO LUIGI as legal representative of INTERPROGETTI GENOVA S.r.l.
- Person responsible for data protection SPOTORNO GIUSEPPE

### b) PERSONAL DATA UNDERGOING PROCESSING

 Non-specific personal data (identification, accounting, financial, etc.) - Personal and banking data - Duration of processing: 10 Years

#### c) PURPOSES, LEGAL BASIS AND MANDATORY OR OPTIONAL NATURE OF PROCESSING.

The source of the data referred to under point b. shall be: Data provided by the person concerned.

Main Purpose: Management of data related to Customer/Supplier: registration of personal data, filing of contracts and invoices, communications through available contact channels (ordinary mail, e-mail, telephone)

Legal basis: The processing is necessary for the pursuit of the legitimate interests of the data controller or of third parties, provided that the interests or fundamental rights and freedoms of data subject, which require the protection of personal data, are not overridden, in particular if the data subject is a minor

Legitimate interest: Relevant to the contractual activity agreed by both parties

### d) RECIPIENTS

Exclusively for the purposes indicated above, the data will be made available, besides the units of internal personnel competent in this regard, also to external collaborators responsible for their processing, the list of which is available at the registered office of the data controller.

## e) TRANSFER

There is no transfer of Personal Data to Recipients outside the European Union.

### f) DATA STORAGE

All personal data provided will be processed in accordance with the principles of lawfulness, fairness, relevance and proportionality, only with the methods, including computer and telematics ones, strictly necessary to pursue the purposes described above. In any case, personal data will be stored for a period of time not exceeding that strictly necessary to achieve the purposes indicated. Personal data whose storage is not necessary or for which storage is not provided by the existing laws, in relation to the purposes indicated, will be deleted or transformed into an anonymous form. It should be noted that the information systems used to manage the information collected are originally designed in such a way as to minimise the use of data.
